

Honor a Frontline Hero Contest

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. The Honor a Frontline Hero Contest ("Promotion") begins at 8:00 am on June 1, 2020 and ends at 8:00 pm on July 31, 2020 ("Promotion Period").

1. **ELIGIBILITY:** The Promotion is open only to legal residents of the Cayman Islands, who are eighteen (18) years of age or older at the time of Promotion registration. Employees, officers and directors of Luxury Cayman Villas (the "Sponsor") and any of its subsidiaries and affiliates, Perfectly Pampered, Family Time Watersports, Chef Carlos Bolaños, Tortuga Fine Wine & Spirits, Property Cayman, their respective parent companies, affiliates, subsidiaries, advertising, and fulfillment and marketing agencies, (collectively, "Promotion Parties") their immediate families (parent, child, sibling & spouse and their respective spouses, regardless of where they reside) and persons living in the same households as such individuals (whether related or not) are not eligible to participate in the Promotion. 2. **TIMING:** The Promotion will consist of three (3) phases, as detailed below:

 - 2.2. **Judging Period:** Begins at or about 8:00 am on August 1, 2020 and ends at 8:00 pm on August 15, 2020
 - 2.3. **Winner Announcement:** The Grand Prize Package winner will be announced on or about August 16, 2020
3. **HOW TO PARTICIPATE:**
 - 3.1. To participate, go to: <https://www.luxurycaymanvillas.com/honor-frontline-heroes> (the "Website") and complete the Honor Frontline Hero Nomination Survey during the Contest Entry Period to gain access to the Contest entry form in order to nominate an eligible "essential worker" as determined by the Cayman Islands Government (if you have not done so previously), who is a resident of the Cayman Islands. Completely enter the information requested in the form fields (required

fields include: Nominator Full Name, Nominator Email Address, Nominator Phone Number, Nominee Full Name, Nominee Place of Employment – Company Name and Address, Nominee Phone Number, Nominee Email Address). Once completing the registration form, you will then be asked to submit a 200-word (or less) essay describing the Nominee's commitment to providing essential services with compassion and supporting the Cayman Islands community regardless of personal sacrifice. Upon completion of the registration form and submission of the essay, you will earn one (1) Entry into the Promotion. **Limit of one (1) Entry per person, per email address throughout the Promotion Period.**

- 3.2. By submitting an Entry, you hereby grant permission for your Entry to be posted on www.luxurycaymanvillas.com or other websites. You agree that Promotion Parties are not responsible for any unauthorized use of Entries by third parties. Promotion Parties do not guarantee the posting of any Entry. You agree that you will not use the Entry for any other purpose, including, without limitation, posting the Entry to any online social networks (other than for entry into this Promotion), without the express consent of Sponsor in each instance. By submitting an Entry, you represent and warrant that the work submitted is original to you and that neither it nor its contents infringes upon or violates the rights of any third party. If your Entry includes likenesses of third parties or contains elements not owned by you, you must be able to provide legal releases for such use in a form satisfactory to Sponsor or your Entry will be disqualified.  - Contains any individual other than the you and/or any materials embodying the names, likenesses, voices, or other indicia identifying any person, including, without limitation, celebrities and/or other public or private

figures, living or dead, without providing legal releases for such use in a form satisfactory to Sponsor;

- Contains look-alikes of celebrities or other public or private figures, living or dead;
- Communicates messages or images inconsistent with the positive images and/or good will to which Sponsor wishes to associate; and/or
- Violates any law.

4.2. By submitting an Entry, you represent and warrant that your Entry is original to you, that the Entry has not been previously published, has not won previous awards and that neither it nor its contents infringes upon or violates the rights of any third party, including any copyrights, trademarks, rights of privacy, publicity or other intellectual property. 4.3. By submitting an Entry, you acknowledge and agree that Sponsor may receive other Entries under this Promotion that may be similar or identical to the Entry submitted by you, and you waive any and all claims you may have had, may have, and/or may have in the future, that any other Entry reviewed and/or used by Sponsor may be similar to your Entry and you understand that you will not be entitled to any compensation because of Sponsor's use of such other similar or identical material.

5. **JUDGING:** Begins at or about 8:00 am on August 1, 2020 and ends at 8:00 pm on August 16, 2020. The judging panel, selected by the Sponsor, will score each Entry up to the maximum amount of points allowed. Judging will be based on the following criteria:

- Extraordinary compassion (25%)
- Support of other frontline workers and colleagues (25%)
- Support of community members (25%)
- Personal sacrifice (25%)

Entries that do not contain all required entry information, or are considered inappropriate for any reason are not eligible. The Entry with the highest score from the Judges will be deemed the potential winner. In the event of a tie, the "personal sacrifice" judging criteria will be deemed the tiebreaker. In the event that a tie still exists after the first tiebreaker, the "extraordinary compassion" Judging criteria will be deemed the tie-breaker. Prize awards are subject to verification of eligibility and compliance with these Official Rules.

6. **WINNER NOTIFICATION:** Prizes will be awarded only upon winner redemption, confirmation, verification and final approval by Sponsor. No substitution, transfer of any prize or cash alternative permitted, except by Sponsor who reserves the right, in its sole discretion, to substitute a prize of equal or greater value, if prize, or portion of prize, becomes unavailable. The potential Grand Prize Package winner will be sent a sworn statement of eligibility/liability release via email.
